For years, South Sound residents did not have local access to a legal education. Through the University of Washington Tacoma Legal Pathways program, we created a bridge from our campus to legal education and careers. Now, we're ready for the next phase.

The South Sound Hybrid Hub is an important partnership between UW Tacoma and Seattle University School of Law, and a great opportunity to serve an underserved community. The program combines virtual and in-person learning and offers broadened opportunities for place-based working individuals and caregivers seeking a legal education.

It's a positive for all the South Sound, including law firms that provide essential services in our communities critical for economic development. More people will be able to get and use their legal education in the place they want to be – Tacoma-Pierce County.
